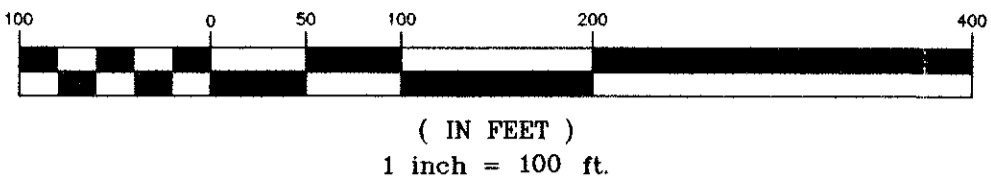


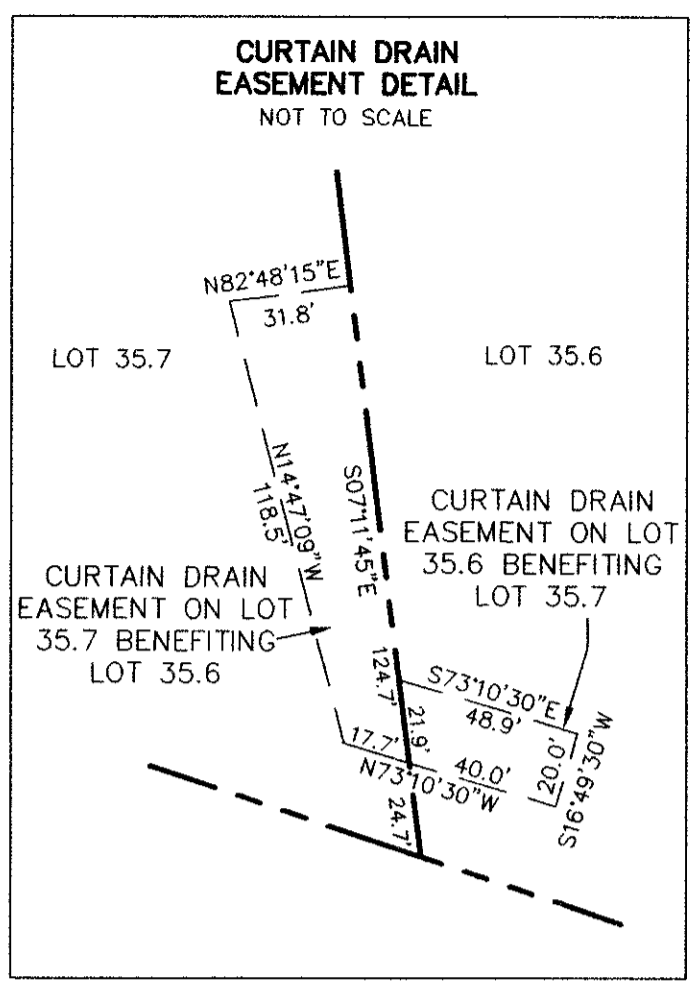
MAP 7 BLOCK 04 PARCEL 1,2

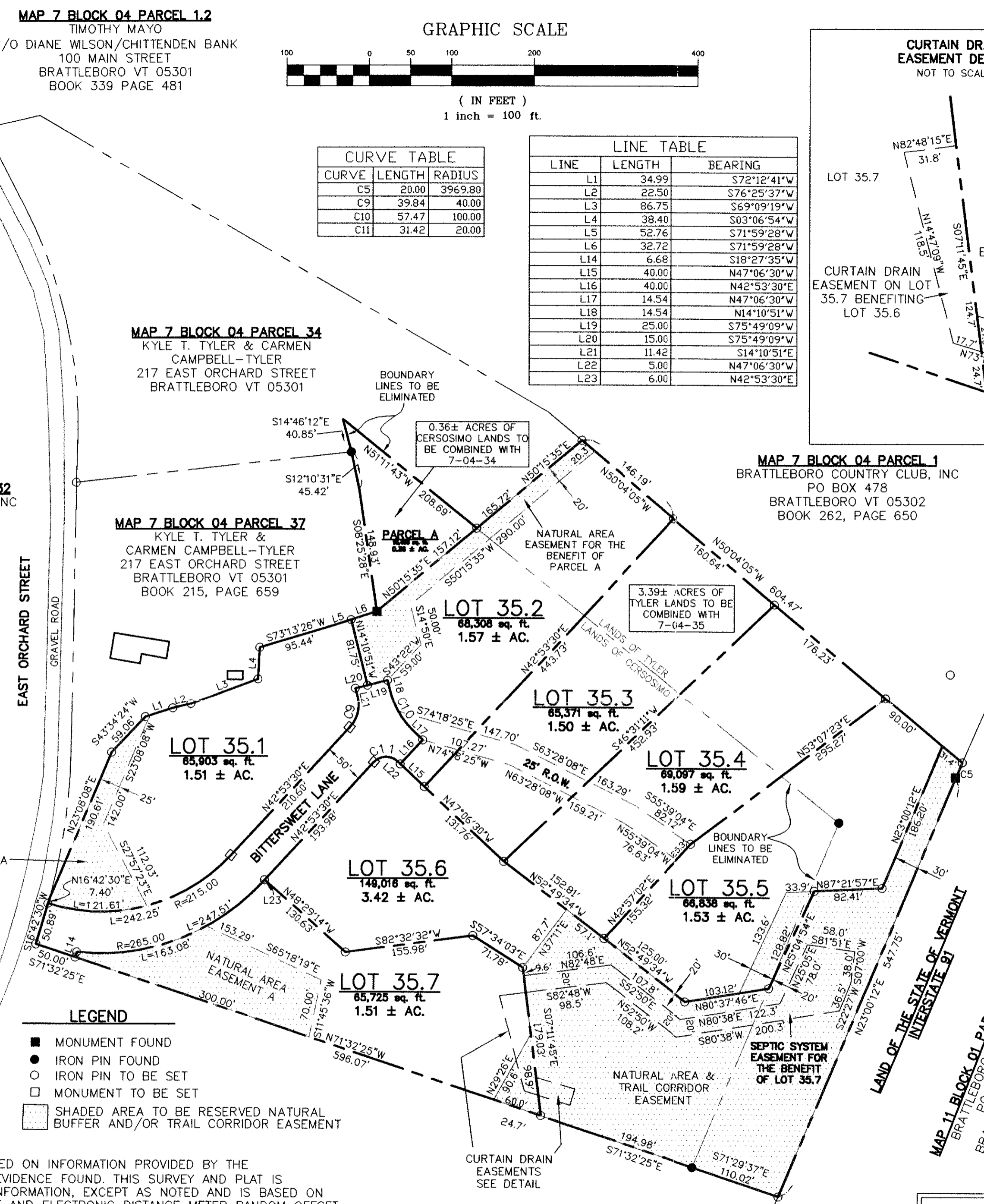


MAP 7 BLOCK 04 PARCEL 34
